#### FLAMMABLE PROPERTIES

**Fire/explosion** NFPA Class IIIB combustible liquid.

**Suitable extinguishing media** Water spray, Alcohol-resistant foam, Dry chemical, Carbon dioxide (CO<sub>2</sub>)

**Protective equipment and precautions for firefighters** Wear self-contained breathing apparatus for firefighting if necessary.

**Methods and materials for containment and cleaning up** Evacuate personnel to safe areas. Remove all sources of ignition. Spilled material will solidify. Sweep up and shovel into suitable containers for disposal. Do not flush into surface water or sanitary sewer system.

**Storage and handling materials** Suitable: Carbon steel coated with baked phenolic. Any moisture may cause rusting of carbon steel. If product is moisture free, uncoated carbon steel tanks.

**Further information on storage conditions** When stored in the liquid form, ethoxylates should be padded with a dry inert gas, such as nitrogen, to prevent oxygen or air from entering the tank. Prolonged storage in the presence of air or oxygen may cause product degradation. Oxidation is not expected when stored under a nitrogen atmosphere. Inert gas blanket and breathing system needed to maintain color stability. Use dry inert gas having at least -40°C (-40°F) dew point.

<b>Conditions to avoid</b>	Reacts slowly with air or oxygen. Storage under heated conditions in the presence of air or oxygen increases reaction rate. For example, after storing at 95°F/35°C for 30 days in the presence of air, there is measureable oxidation of the ethoxylate. Lower temperatures will allow for longer storage time and higher temperatures will shorten the storage time if stored under an air or oxygen atmosphere.
